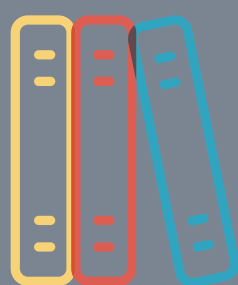


## WHAT IS A FORENSIC SCIENTIST?

A person who examines evidence from crime scenes. A forensic scientist develops objective findings based on results obtained during the examination and analysis of crime scene evidence. These facts are reported in an unbiased manner to be used for the prosecution of perpetrators or to determine the innocence of wrongfully accused individuals. Forensic Scientists provide courtroom testimony as needed for criminal prosecution.



## WHAT ARE THE EDUCATIONAL & OTHER REQUIREMENTS FOR A TBI SPECIAL AGENT FORENSIC SCIENTIST?



- ✓ Bachelor's Degree in natural science (i.e. biology, chemistry, biochemistry, microbiology, molecular biology, physics, etc.)
- ✓ 24 semester hours of chemistry (36 quarter hours of chemistry)
- ✓ Ability to pass an in-depth background investigation

Starting salary for a special agent forensic scientist is \$3,777 per month, which is \$45,324 annually.

## DO TBI FORENSIC SCIENTISTS PROCESS CRIME SCENES?

Yes. TBI special agent forensic scientists process crime scenes for local law enforcement agencies that are not equipped to process these scenes as well as all officer-involved shootings, as requested by the District Attorney General.
